TICKANWÁTIC IAI TERRITORY, MISNOMER FORT BEND COUNTY, TEXAS: Tickanwátic Kingdom Commonwealth Concerned by Persistent Violations of Eternal Laws, International Humanitarian Law and Human Rights

Delegates Condemn Attacks on IAI RoYaL Embassies and IAI International Protected Peaceful People

Nearly six years following the trespass, invasion and unlawful removal of an internationally protected peaceful IAI De Jure Foreign National Ambassador and Diplomats from their declared embassy and private lands in Williamson County, Texas, the suffering of IAI RoYaL VesseLs continue unabated.

The State of Texas and Fort Bend County’s actions disregard fundamental principles of Eternal Laws, purview “Is It Not Written In” Non-Derogable Jus Cogens Peremptory Norms Customary International Law, avowed the Tickanwátic Ibri Abar’Rishoni People’s Expert Counselor-At-Law of the Land.

Expert Counselor-At-Law of the Land for Tickanwátic Kingdom Commonwealth, an Original American Indian Sovereign Governance, asserts that Fort Bend County, Texas, et al., all others, and other foreign authorities persist in committing serious violations of international human rights and international humanitarian law, particularly concerning cases involving IAI De Jure Foreign National Diplomats, also known as Private Secured Parties. IAI Peaceful De Jure Foreign Nationals have neither waived nor shall waive their inherent unalienable rights as per “Is It Not Written In” Foreign Sovereign Immunity Act devoid of State of Texas, Fort Bend County, Texas jurisdictions and it’s extensions.

Tickanwátic True Court of Records exercising Absolute Inherent Universal Jurisdiction (IUJ), alongside First Nation People Embassy (FNAP-E) True Court of Records IUJ, have not received file-stamped affidavit responses from the State of Texas, Williamson County, Texas or Fort Bend County, Texas. These United States instrumentalities remain in Want of Jurisdiction while engaging in serious grave war crimes such as anti-Shemetic and anti-Aboriginal gas lighting terroristic threats, attacks and bombardment upon international protected IAI embassies and IAI RoYaL Ambassadors, Consulates and RoYaL VesseLs.

Tickanwátic Kingdom Commonwealth is deeply troubled and concerned by the ongoing use of armed force to imidate and unlawfully forcibly remove IAI RoYaL VesseLs from lawfully declared embassies, private lands and private properties. These devastating attacks inflict insurmountable pain, suffering and peril upon internationally protected peaceful people, inclusive of women and children who endure these relentless acts of aggression amounting to grave war crimes.

“Our lives are gravely endangered due to the relentless violations and grave war crimes that the Counselors-At-Law of The Land have meticulously documented across our ancient lands spanning from east to west and north to south.” stated Tickanwátic Expert Counselor-At-Law of the Land. “The systemic and systematic assaults embedded in racism is a clear breach of international humanitarian law, perpetrated by the State of Texas, Fort Bend County and Williamson County, results in the purposed destruction and devastation of IAI embassies, IAI RoYaL artifacts including culturally significant items and essential food supplies. Further investigations have uncovered compelling evidence of unlawful acts targeting women and children, leading to the forced displacement and immediate humanitarian crises.”

Tickanwátic IAI People are highly concerned for our lives due to the unrelented weight of violations and grave war crimes that the Expert Counselors-At-Law of The Land, Counsel Generals, KaSikees and UnderKaSikees has investigated across inoivable IAI demarcated ancient lands. The systemic and systematic attacks violating international humanitarian law committed by the State of Texas, Fort Bend County and Williamson County together has led to immeasurable destruction and damage of IAI RoYaL Embassies, IAI RoYaL VesseL objects inclusive of objects such as cultural property, food and medical supplies. Investigations found additional evidence concerning the unlawful acts committed against women and children in circumstances which amount to unlawful displacement and abrupt crisis.

Tickanwátic vehemently condemns all violations and crimes against its RoYaL IAI Embassy and IAI De Jure Foreign Nationals, officially sanctioning the State of Texas, Fort Bend County, Texas, et al. all others.

Tickanwátic Nation Expert Counselors-At-Law of The Land will formally present the findings of these investigations to relevant international and domestic authorities, driven by profound safety concerns for IAI Foreign National Ambassadors, Diplomats, Consulates and RoYaL VesseLs, IAI demarcated territory thereof
